





Q36. How much corruption do you think there is in the public sector? [A LOT, SOME, A LITTLE, NONE]










LEVEL OF GOVERNMENT WHERE CORRUPTION HAPPENS, BY AREA, 2013








LEVELS OF GOVERNMENT EMPLOYEES WHERE CORRUPTION HAPPENS THE MOST, BY AREA, 2013

















Q4. When there is corruption involving a businessman and a government official, who in your opinion is to blame?










OPINION ON HOW OFTEN THE GOV'T PUNISHES CORRUPT GOV'T OFFICIALS, BY AREA, 2013










EXCELLENT SINCERITY RATING IN FIGHTING CORRUPTION








EXCELLENT IN FIGHTING CORRUPTION:

OFFICE OF THE PRESIDENT, BY AREA, 2009 TO 2013












VERY GOOD IN FIGHTING CORRUPTION: DTI, BY AREA, 2009 TO 2013












VERY GOOD IN FIGHTING CORRUPTION: <u>DOH</u>, BY <u>AREA</u>, 2009 TO 2013












VERY GOOD IN FIGHTING CORRUPTION: SSS, BY AREA, 2009 AND 2013















GOOD IN FIGHTING CORRUPTION: <u>DEPED</u>, BY AREA, 2009 TO 2013







YOUR CITY GOVERNMENT, BY AREA, 2009 TO 2013
















"NEUTRAL" IN FIGHTING CORRUPTION: TRIAL COURTS, BY AREA, 2009 AND 2013









BY AREA, 2009 TO 2013














NEUTRAL IN FIGHTING CORRUPTION: DOTC, BY AREA, 2009 TO 2013









BY AREA, 2009 TO 2013















HOUSE OF REPRESENTATIVES, BY AREA, 2009 TO 2013






























SPENDING IN THE LAST 2 YEARS TO COMBAT FRAUD AND CORRUPTION IN OWN COMPANY,












ENTERPRISES WITH A WRITTEN CODE OF ETHICS, BY AREA, 2012 AND 2013



Q106. Does your company have a written code of ethics or written rules about punishments for corruption? IF YES: What year did you have it?














ALMOST ALL/MOST COMPANIES IN OWN LINE OF BUSINESS PAY TAXES HONESTLY, BY AREA, 2012

Q49. In your sector of business, how many companies do you think pay taxes honestly?





Q50. In your sector of business, how many companies do you think issue receipts for all revenues?










ALMOST ALL/MOST COMPANIES IN OWN LINE OF BUSINESS KEEP ONLY ONE SET OF ACCOUNTS,

Q51. In your sector of business, how many companies do you think keep only one set of accounts/books?










ALMOST ALL/MOST COMPANIES IN OWN LINE OF BUSINESS **DEMAND**

Q52. In your sector of business, how many companies do you think demand receipts for all payments for expenses?










NUMBER OF COMPANIES IN THE LINE OF BUSINESS THAT

Q54. In your sector of business, how many companies do you think pay the correct wages of their employees?










PERCENT SATISFIED WITH THE

Q128. How satisfied or dissatisfied are you with the National Government's performance in promoting a good climate for business in the Philippines?



Why Design Challenge?


- The Philippine economy cannot be built on a few cities. We need more urban areas; more drivers
