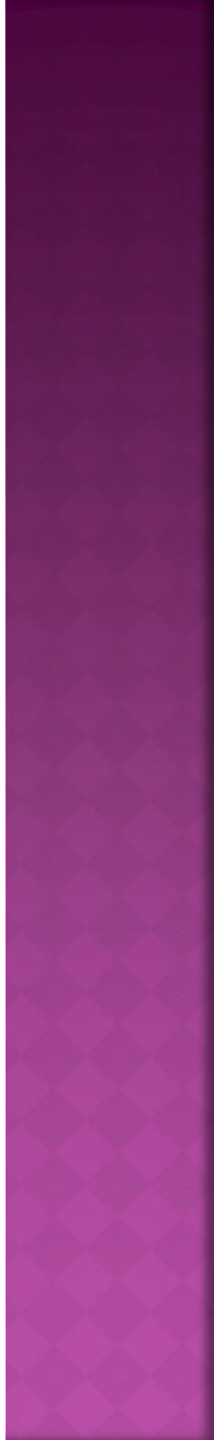

# **What are the Priority Programs of NABPLO at Present?**

1. Expand NABPLO membership to cover all regions of the country.
2. Hold monthly fellowships among its members.
3. Hold an annual National Convention.
4. Foster closer relations with the D T I, D I LG and D O F.
5. Establish linkages with national business chambers and organizations.

# **What are the Priority Programs of NABPLO at Present?**

6. Clarify issues and concerns with NGAs that have concurrent regulatory powers over local businesses like PEZA, GAB, etc.
7. Hold regular training programs for BPLO staff to increase professionalism and competency.
8. Establish and maintain a well-staffed NABPLO Secretariat to service the needs of its members.
